Article 5: Payment

Article 6: Quality and Quantity, Discrepancy and Claim

As for quality, if the customer purchases USED MINER, it is necessary to confirm the quality of the machine with the seller before the goods are delivered. Once the goods are delivered, they are deemed as qualified.

In case the quantity is found by the Buyer to be not in conformation with the stipulated in the Contract at the port of destination, the Buyer may lodge claim against the Seller by survey report issued by an inspection organization agreed upon by both parties, with the exception, however, of those claims for which the insurance company and/or the shipping company is to be held responsible. About quantity discrepancy claim should be filed by the Buyer within 15 days after arrival of the goods at the port of destination. The Seller shall within 30 days after receipt of the notification of the claim, send reply to the Buyer.

Article 7: Force Majeure

In case of force majeure, the Seller shall not be held responsible for late delivery or non-delivery of the goods but shall notify the Buyer by email. The Seller shall deliver to the Buyer by registered mail, if so

requested by the Buyer, a certificate issued by the Poland Council for the Promotion of International Trade or any competent authorized.

Article 8: Arbitration

All disputes in connection with this Contract or the execution thereof shall be settled by negotiation between two parties if no settlement can be reached, the case in dispute shall then be submitted for arbitration in. In accordance with the arbitration regulations of the arbitration organization of Czech republic, the decision made by the arbitration organization shall be taken as final and binding upon both parties. The arbitration expenses shall be borne by the losing party unless otherwise awarded by arbitration organization.

Article 9: Warranty, Delivery, Clearance

New miners have 1 year warranty from factory. During the warranty period, if there is a quality problem, after-sales service can be provided to ensure that the machine cannot be disassembled. The used miner has 6 months warranty, so it is necessary to confirm the quality of the machine with the seller before the goods are delivered. Once the goods are delivered, they are deemed as qualified. The miners shall be sent to your door, and the Buyer is responsible for customs clearance.
